John Rook began the presentation about Private Utility Locating.

- They do a lot of work on hospitals (95%), pharmacies, military installations, apartment complexes and schools.
- Currently they are trying to partner with 811 in each state.
- He discussed the differences between public utilities and private utilities
 - Showed diagrams to have audience point out public vs private lines
- Biggest challenges
 - o People think that 811 is the law and they mark all underground lines.
 - Records are incomplete/missing/inaccurate
 - o Non-metallic lines
- They use several methods:
 - Ground penetrating radar
 - Vacuum excavation
 - Concrete scanning
 - Cross bore mitigation
 - Sewer excavation
- Vita: Their water leak detection might be a good resource for customers
- Vita: If you are locating, is it on an hourly basis?
 - o John: Yes, mostly hourly, except some vacuum excavating jobs
 - o Vita: What would an average bill be?
 - o John: \$160-200/hour for complete hour
 - o Vita: Do you have rates?
 - o John: No rates, just give us a call and we can discuss.
